This Addendum shall be part of the Specifications and Drawings for this project and shall be part of the actual contract document to complete the work. When the Architect issues an Addendum, it is the Bidder's responsibility to copy and insert it into the bid documents they have obtained from the Architect or Owner.

There are Two (2) items in this Addendum.

## ITEM NO. 1: DRAWINGS, HV0.1 PARTIAL SECOND FLOOR PLANS - HVAC DEMOLITION

 HVAC Demolition Drawing Notes – Revise note 6 to read as follows: "REMOVE EXISTING AIR HANDLING UNIT AND ALL ASSOCIATED DUCTWORK, DAMPERS, PIPING, VALVING, CONTROLS, HANGERS, SUPPORTS, INSULATION, CONDENSATE PUMP, SMOKE DETECTOR, DISCONNECTS ETC."

## ITEM NO. 2: CLARIFICATIONS

- 1. The working hours within the Baling Area of the Transfer floor shall be limited to Tuesday through Friday between 4:00 PM and 5:00 AM of the following day or between Saturday at 12:00 PM to Tuesday at 5:00 AM, inclusive of Sunday and Monday with no hourly restrictions. Work hours and access must be coordinated with the owner. All other work areas will be accessible at any time.
- 2. The elevator may be used by the contractor. If used, the cab must be protected, and the material shall not exceed the posted maximum weight limit. Photos must be submitted to ARCON and the owner prior to use.
- 3. Staging of Crane lifts shall not impede travel around the perimeter of the building. Parking spots and the grass area around the building can be utilized. Lifts can occur anything allowed by local codes. It is the contractor's responsibility to ensure that there are no building occupants below the radius of the crane's boom during crane activities. All pick times shall be coordinated with the owner.
- 4. There will be a roofing contractor on site during the duration of the project (Riddiford Roofing). It is imperative that all Mechanical Improvement work is coordinated with the with Riddiford Roofing.
